



## First Industrial Realty Trust, Inc. Announces Pricing of Common Stock Offering

CHICAGO, March 30, 2016 /PRNewswire/ -- First Industrial Realty Trust, Inc. (NYSE: FR) ("First Industrial" or the "Company") today announced the pricing of its underwritten public offering of 5,600,000 shares of its common stock.



First Industrial will receive approximately \$126 million of gross proceeds, before deducting underwriting discounts and commissions and estimated offering expenses. The Company intends to use the proceeds for general corporate purposes, which may include development and/or acquisition of properties and repayments of debt. Completion of the offering is subject to customary closing conditions.

BofA Merrill Lynch and Wells Fargo Securities are acting as the book-running managers for the common stock offering.

The shares of common stock are being offered under the Company's shelf registration statement, including a prospectus filed by First Industrial with the Securities and Exchange Commission on March 13, 2014.
